Accessing the State of Oregon Law Library fastcase®

Available to all Oregonians, Fastcase includes the United States Code, United States Supreme Court and Court of Appeals Cases; and cases, statutes, regulations, court rules, constitutions, attorney general opinions, and session laws for Oregon, Alaska, Arizona, California, Idaho, Montana, Nevada, and Washington. Access is remote.

First-time users

Users need to create a free account for access.

NOTE: This account will also allow access to HeinOnline.org

1. Using your browser visit the url: <https://soll.libguides.com/fastcase>
2. Click the bolded text **Create an Account**.



3. Click **New User? Register here**.



4. Enter and confirm your **First Name**, **Last Name**, **User Name** and **Password** information.
